### What to Know About New Jersey's Route 495 Bridge Rehabilitation Project to Lincoln Tunnel

It's time for the main event of the \$90.3 million project to replace the 80-year-old viaduct that carries Route 495 over Routes 1 and 9. Two lanes are now closed on the Route 495 bridge to and from the Lincoln Tunnel, and they will remain closed until the summer of 2021.

The bridge is rated as structurally deficient and functionally obsolete, and the rehab project is expected to extend the useful service life of the bridge for an estimated 75 years and eliminate the need for potential emergency repairs.

Route 495 is one of the most critical roadways in the region connecting New Jersey Turnpike, Route 3 and the Lincoln Tunnel. It is also one of the most congested roadways and it is going to get more congested as this bridge is in need of significant repair to the deck, and to the structural steel.

The traffic pattern will change eight times during the project, beginning with one center lane in each direction. The exclusive bus lane – the most heavily used in the country – will remain open eastbound between 6 a.m. to 10 a.m.

Drivers are urged to find alternate ways to get in and out of the city. Route options for driving:

- George Washington Bridge
- Holland Tunnel (Pulaski Skyway is fully open to Holland Tunnel)
- Staten Island Expressway, Verrazano Bridge and Gowanus Expressway
- Use the Western Spur of I-95/NJ Turnpike to avoid congestion

Other tips for drivers:

- Travel before 6 a.m. or after 9 a.m.
- Use park & ride and carpool lots

• Don't drive. Use PATH, NJ TRANSIT Bus and Rail, and/or a ferry

NJ TRANSIT is encouraging drivers looking to avoid traffic to utilize the nearby Vince Lombardi Park and Ride, which has parking capacity to accommodate additional customers. In addition, 136 parking spaces were added to the North Bergen Park & Ride as part of the Route 495 project.

NJ TRANSIT Bus Commuters:

- AM: Routes remain the same to Port Authority Bus Terminal
- PM: Potential for longer travel times Truckers:
- Travel Eastbound before 6:00 a.m.
- North-South travel: use Western Spur of NJ Turnpike

### Affordable Housing Alliance (AHA) Reports a 265 Percent Return on Their Investment in the Ryde4Life Program

ince its founding in 1991, the required and they could travel to any Affordable Housing Alliance (AHA) of Monmouth County, a private, nonprofit organization has been providing housing-related assistance for the disabled, low-income and single parents. Its mission is to improve the quality of life for all New Jersey residents by developing and preserving affordable housing, by providing services to maintain housing affordability, by providing housing education, and by helping communities meet their legal and moral housing obligations.

Transportation was a challenge for their clients. The houses were located far from stores, doctors or employment centers and most of their clients did not own a car and could not afford to pay for taxi services. As a result, they were forced to depend on others for transportation. The services were not always reliable and they would often arrive late for work or not at all. The daily struggle spurred the AHA to seek more reliable and affordable transportation solutions for their clients.

In February 2018, AHA decided to launch a pilot transportation program with EZ Ride. The goal was to provide reliable and affordable transportation for their clients which would help them to find jobs, access healthcare services, attend schools or visit stores to shop for their daily needs.

A dedicated transportation account for up to \$1,000 was set up for each client. When needed, the client could call a toll-free number and request transportation - no advance reservations or approvals were

location in New Jersey, New York (except the five boroughs) or Pennsylvania. AHA would replenish the account as needed upto the maximum amount of \$1,000.

EZ Ride provided the service using the Ryde4Life program with Lyft as the transportation vendor. AHA paid the fees charged by Lyft along with a \$1 administrative fee. The EZ Ride coordinators monitored the rides in real time and were available for any assistance. Additionally, they reviewed the invoices from Lyft to ensure the billing is correct.

Donna Blaze, CEO Affordable Housing Alliance, says, "In February 2018, AHA decided to partner with EZ Ride to provide their clients with affordable transportation to access jobs and social services. About 20 clients joined the program and they have taken over 600 rides, averaging a nominal cost of \$17 per ride. We have found that for every \$1 invested in transportation, the client has been able to generate \$2.65 in additional income – a 265 percent sustainable return on investment."

Claire W. Williams, Fanwood Member since June 2011

Claire Williams was raised in Orange and lived in Roselle before moving to Fanwood. She was hired as part of the first group of African American women at NJ Bell and worked there for 44 years.

She is 92 years old and has been using EZ Ride transportation services for seven years. Last year, she signed up to participate in the new Ryde4Life program and used the service primarily for visits to the doctor and shopping. Claire says the program has improved her quality of life. She says, "The best part of the service is that no reservations are required. I call EZ Ride, and the car shows up in a few minutes. I enjoy the independence to come and go without having to rely on others. What more could I ask for?"

The *Ryde4Life* program is available state-wide, all seven days of the week. Additionally, the service has been expanded to serve all adults 18 years or older.

# October is International Walk & Bike to School Month - Join the Celebration

International Walk to School Day is a global event that involves communities from more than 40 countries walking and biking to school on the same day. It began in 1997 as a one-day event. Growing interest from all over the world led the International Walk to School Committee to promote International Walk to School Month during the whole month of October.

October 10th is this year's International Walk and Bike to School Day, and students and parents all over New Jersey will be walking and bicycling to school and participating in walk and bike events.

The EZ Ride *Safe Routes to School* (*SRTS*) team has consistently encouraged and supported schools to participate in the event. More than 80 schools in New Jersey have already registered to participate in the event. All participating schools are requested to register their event on the website: www. walkbiketoschool.org.

These events help increase awareness about the importance of physical activity, encourage healthy lifestyles among children, address bicycle and pedestrian safety, traffic congestion, and concern for preserving the environment.

Various studies have shown that students who are physically active on the way to school arrive ready to learn and perform better in class.

To encourage safe walking and biking, EZ Ride offers free walking and biking safety presentations and a Safe Skills Riding Course to help kids practice the skills needed to safely bicycle in neighborhood traffic. Bike events include a pre-ride safety check, helmet fitting, bicycle handling, safety drills, hand signals and dealing with cars on the road. For schools who participate in walk to school day with EZ Ride, we will provide free coloring books about walking safety.
