New Jersey Sports & Exposition Authority (NJSEA) Launches 2045 Meadowlands District Transportation Plan (MDTP 2045)



expertise of the staff from the NJSEA Transportation Group and an outside consultant, this project will evaluate the District's transportation needs, identify multi-modal improvement project candidates and cost estimates, and update the District's transportation impact fee framework and calculation methodology. The Meadowlands District comprises of 14 contiguous towns in Bergen and Hudson counties. In addition, NJSEA will be forming a Technical Stakeholders Group (TSG), which will meet three times to provide input in to the project development. EZ Ride Board Chair, Perry Frenzel,

P.E., P.P., will represent EZ Ride on the TSG to share our insights with NJSEA and the consultant team.

EZ Ride Representative to Serve on the Meadowlands Transportation Planning Board (MTPB)



In 2005, the Hackensack Meadowlands Transportation Planning Act **established a Transportation Planning District** within the Meadowlands District. The Meadowlands Transportation Planning Board (MTPB) is composed of the Commissioner of the New Jersey Department of Community Affairs or a designee; the Commissioner of Transportation or a designee; a representative from EZ Ride (earlier known as Meadowlink), a representative of the Hackensack

Meadowlands Municipal Committee, a representative of the Meadowlands Regional Chamber of Commerce; and four public members appointed by the Governor. THE MTPB will play an important role in the administration of the MDTP2045 project, including reviewing draft work products and approving the plan. EZ Ride Board Chair, Perry Frenzel, P.E., P.P., will represent EZ Ride on the MTPB.

Asbury Park - Ryde4Life Program Monthly Ridership Increases from 60 to 260 a Month



Thanks to a generous grant from the New Jersey Health Initiatives (NJHI), EZ Ride, in conjunction with the Alliance of Healthier Asbury Park, provided rides at no cost to Asbury Park residents. The **Ryde4Llife program** offers rides for adults 18 or older in partnership with Lyft and Uber. In the last six months (May to October), the monthly ridership has

increased from 60 to 260. About half the rides are for medical trips and the remainder for grocery shopping. The funding is available until December 31, 2020, but the need for affordable transportation continues to grow. The service is provided M-F from 8 am - 5 pm, and riders are requested to call 201-939-4242 ext.4. No reservation is required.

City of Montclair Taps Ryde4Life Program to Provide Free Rides for its Senior Residents



As a result of COVID-19, the City of Montclair has opted to replace their senior shuttle with the **Ryde4Life program** which uses Lyft and Uber to provide rides. The free service is open to all residents aged 55 or more and individuals with a disability. Trips outside the town require prior approval from the Township. Riders can schedule their rides Monday — Friday 8 am — 8 pm and on

Safe Routes to School Recognition Deadline - January 31, 2021



The federally funded SRTS program promotes safe walking and biking. Grade K-8 schools and municipalities that participate in the program can earn state recognition awards and earn bonus points when applying for NJDOT infrastructure grants or Sustainable Jersey for

Schools and **Municipalities**. The SRTS recognition program runs from February 1, 2020, to January 31, 2021, and the deadline to apply is January 31, 2021. EZ Ride can help your school or municipality meet the **award criteria** at one of four levels: First Step, Bronze, Silver, or Gold.
