### 5 local Schools Earn Awards for Promoting Student Health and Safety

ew Jersey Safe Routes to School (SRTS) is a statewide initiative supported by the New Jersey Department of Transportation (NJDOT) with funding from the Federal Highway Administration to create safer and more accessible environments for students to walk and bicycle to and from school.

Meadowlink helps schools to implement the SRTS program by offering hands-on workshops, informative presentations, demonstrations, audits and fun-filled events to encourage the participation of students, teachers, administrators, and parents. The events are designed to teach safe walking/biking practices and improve the behavior of all road users with the goal of creating a culture and environment where walking and biking to school is a safe and attractive way of life for students in New Jersey.

Participating schools are eligible for *SRTS* awards based on their commitment and support of the program. Enrolling in the program is the first step. The awards recognize the level of commitment achieved by the students and the attainment of specific goals. The five schools that were recognized in our area were: Montclair, *Edgemont Motessori School* (gold); Montclair, *Bradford School* (silver); Garfield, *Woodrow WilsonElementarySchool*; Montclair township (bronze); and Maplewood, *Tuscan Elementary School* (first-step).

# **Meadowlink** Awarded Top Urban Community Transportation System of the Year

he Community Transportation Association of America (CTAA) recently recognized Meadowlink as the 2013 Urban Community Transportation System of the Year at their annual conference, held in Albuquerque, NM., in June.

The award, presented annually at the CTAA national EXPO, recognizes excellence by urban transportation systems in serving the needs of people in their communities. Meadowlink was selected for "innovative and creative collaborations throughout its service area, which includes some of New Jersey's most populous counties," according to Ann August, Secretary of the Association's Board of Directors, who presented the award.

Ms. August highlighted two of *Meadowlink* a non-profit, public-private *Meadowlink* programs as being partnership, helps improve access to especially innovative and collaborative: affordable transportation, reduce

• Community Cars, a volunteer driver program that serves as a transportation lifeline for isolated senior citizens. The program currently provides more than 1,000 trips a month, a five-fold increase over the

- 200 monthly trips provided during the program's initial year of 2009; and
- Flex-T, a program that provides employment transportation to individuals with disabilities. After initially providing 637 trips in 2010, Flex-T provided more than 10,000 trips in 2012

Meadowlink's Executive Director, Krishna Murthy, accepted the award on behalf of the company and its employees. He thanked the CTAA for selecting Meadowlink for the award; the Meadowlink board of directors for their vision and support; and its private and public sector partners, including the North Jersey Transportation Planning Authority and NJ TRANSIT, for their funding and ongoing support.

# Schools, Students 'WIN' with Ridgewood's Road-safety Program

ith safety for school children as the driving goal, the Ridgewood School system turned to *Meadowlink* for help. As part of the *Safe Routes to School (SRTS)* program, *Meadowlink* helped tailor a curriculum on road safety for more than 4,000 students who attend seven Ridgewood schools.

#### A 'Win' for all

"The program encourages kids to walk to school and maintain a healthier lifestyle," said Krishna Murthy, *Meadowlink's* Executive Director. "Kids arrive at school alert and ready to learn. The community benefits from reduced traffic, less pollution and cleaner air. It's a win for all."

New Jersey's Health and Physical Education standards, require schools to address issues of safety, personal growth, interpersonal communication, decision making and goal setting as well as physical activity to maintain skills to support a healthy and active lifestyle. *Meadowlink's Safe Routes to Schools (SRTS)* program will help schools be compliant with the New Jersey state mandate by addressing the issues of pedestrian and bicycle safety.

#### **Training the Teachers**

A "Train the Trainer" workshop is conducted, which could be included as part of the teachers' professional development requirements. Meadowlink's training session provides information on road and bicycle safety techniques to be passed on to the students.

#### Designing a curriculum

After teachers are trained, *Meadowlink* team members meet with them to help develop a blueprint for *SRTS* activities that are tailored to the community and

cover all aspects of road safety, whether students choose to walk or ride their bikes.

## Presenting the program to the children

Once the training workshops and the curriculum are completed, the teachers are fully equipped to present and teach children about pedestrian and bicycle safety. "The program benefits schools on many levels," said Jeanne Johnson, *SRTS* Coordinator at Ridgewood Schools. "Teachers fulfill their Professional Development requirements; students embrace a healthier lifestyle by walking or riding to school; and parents often connect with other families."

#### Follow-up programs

Many schools request follow-up events to reinforce the training, such as Pedestrian Safety presentations which support the "Walking School Bus," a fun and safe way to walk to school, a "Bike Rodeo" and "Cycling Skills" event to reinforce bicycle safety skills.

#### No cost to schools

SRTS programs are federally funded and there is no cost to local schools. Nationally, SRTS programs are administered in 10,000 schools and they are growing on a state-by-state basis. In partnership with the New Jersey Department of Transportation (NJDOT), Meadowlink receives federal funds to help implement the program in New Jersey schools.

### 45 sign up to Carpool in Union Beach

Inc, (IFF) located in Union Beach, NJ recently hosted a health fair to bring together health care professionals including nurses and chiropractors. Meadowlink was invited to attend the fair in order to promote carpooling for IFF employees and signed up 45 employees.

Carpooling is one of the oldest, most popular ways to share a ride. Co-workers, fellow students and neighbors who share a common destination get together and share the cost of their commute.

Savings add up quickly – and can easily exceed \$2,000 a year – depending on the distance travelled, the number of passengers and the price of gas and tolls.

## **Service Updates**

### Shore EZ Ride Shuttle Concludes its Voyage

cooperative effort between *Meadowlink*, *NJ TRANSIT*, the shore communities of Asbury Park and Long Branch, and the North Jersey Transportation Planning Authority has ensured operation and the success of the Shore EZ Ride Shuttle service for the past three years.

The NJTPA's Congestion Mitigation and Air Quality (CMAQ) Local Mobility Initiatives program provided start-up funding for the shuttle's first three years. It contributed 75% of the cost towards providing a shuttle service for tourists and residents alike, connecting the Asbury Park and Long Branch rail stations to the beaches and shopping. The remaining 25% of the funding came from the cities of Asbury Park and Long Branch.

At the end of this summer, the service will come to an end unless any new revenue or funding streams are found.

This summer the *Shore EZ Ride* Shuttle service helped transport more riders than ever before. Over 800 visitors to the Asbury Park and Long Branch beaches took advantage of the shuttle over the recent July 4 weekend alone, a testament to the success of the program.

"In recent years, getting to the beach and then finding parking is a challenge in many of New Jersey's beach communities," said Perry Frenzel, Chairman of *Meadowlink*, which operates the Shore EZ Ride service. "So, having a shuttle service direct from the station to the beach is a real advantage."

In addition to providing much-needed transportation to and from the beaches, the program helps to reduce traffic congestion, improve air quality and helps alleviate parking shortages during peak periods.

Ridership has increased steadily since its inception in 2011, from 50 riders per day to more than 200. The service is available from 9 a.m. to 11 p.m. on Fridays, Saturdays and Sundays all the way through to Labor Day. Transit passengers ride for free with others paying a nominal fee of \$1 per ride.
