### **I. Introduction**

1. As part of Phase I of our multi-phased redevelopment plan, Meadowlands Transportation Brokerage Corporation, d/b/a EZ Ride (hereinafter, "EZ Ride"), hereby requests proposals from competent professional construction firms to execute the construction on a piece of land included in Block 249, Lot 1.01 (earlier known as Block 249, Lot-3), that improvement being a paved parking lot with the appurtenances described more precisely in the Scope of Services below.
2. Pursuant to the EZ Ride Procurement Policy, more than one proposal is expected and factors other than price may be taken into consideration for their evaluation.

### **III. Scope of Services**

1. All firms submitting proposals shall be licensed in the State of New Jersey. The general scope of services requires the successful respondent to construct a parking lot according to the detailed engineering drawings and specifications, which are included with this RFP and marked as **Exhibit A**. The Terms and Conditions of this construction project are described in our Fixed Price Construction Agreement, which is included with this RFP and marked as **Exhibit B**. Further, the firms submitting proposals are required to confirm they will comply with the terms of the Fixed Price Construction Agreement, Exhibit B, included with this RFP. The

proposers are welcome to list reasonable modifications they may seek to Exhibit B.

2. Purchase and installation of EV chargers is not within the scope of services and will be undertaken by EZ Ride after the completion of construction.
3. Proposals must demonstrate the firm's level of expertise, technical knowledge, and competence with construction of EV charging stations.
4. Documents prepared by the contractor shall be in an electronic format and shall be made available to EZ Ride in PDF format.
5. The construction shall take into consideration the applicable regulations and guidance from all governmental agencies having jurisdiction including but not limited to the Borough of Wood-Ridge, County of Bergen, Bergen County Utilities Authority, Bergen County Soil Conservation Service, New Jersey Department of Environmental Protection, and the Federal Aviation Authority.

For the avoidance of doubt, the selected construction firm shall perform the construction services only in accordance with more particularly detailed specifications to be set forth in a binding contractual arrangement (Exhibit B) to be entered into between the selected construction firm and EZ Ride.

#### **IV. Proposal Format**

Proposals must be submitted using the format described below, and in the order specified. All pages must be numbered sequentially, including any attachments, appendices and exhibits.

1. Executive Summary: A concise one-page overview of the proposal, highlighting the key tasks and deliverables.
2. Company Information: Provide a two-page or less narrative description of your organization including its history, mission, values, organizational structure, and key personnel. Include relevant licenses, certifications, and insurance information.

4. Experience and Qualifications: Information about the respondent's relevant experience and qualifications. This can include case studies, examples of past projects, client testimonials, and resumes of key team members who will be working on the project. Include information on any subcontractors or partners.

6. References: Contact information for previous clients or partners who can provide references. These should be individuals or organizations that can speak to your capabilities and past performance. Include at least three references from similar projects.
7. Appendices: Any additional information or supporting documents that strengthen the proposal. This can include detailed technical documents, project management plans, certifications, and any other relevant materials.

**V. Proposal Submission Instructions:**

2. Participants should include all proposed alternatives in a single submission.
3. EZ Ride hereby confirms that all proposals received will be kept confidential.
4. ***Cost Proposal - Bidders shall submit a Fixed Price Cost Proposal*** (i.e. 'Lump Sum'), in which the individual items of work are identified with the take-off quantities and unit prices. The total of all estimated costs for each individual item shall be the Fixed Cost upon which the bid will be evaluated. The unit prices in the Fixed Price Cost Proposal shall be utilized as the basis for any future change-orders for overages and or deductions { if necessary) for major changes in quantities due to unforeseen modifications of the project scope. All Fixed Price Cost Proposals shall be based upon the Project Drawings which have been provided to all prospective bidders with this Request for Proposals.
5. No bids will be accepted after the date and time indicated herein for receipt of Proposals.
6. EZ Ride reserves the right to reject all proposals that have not been submitted in accordance with the Proposal Submission Instructions in Section V.

**VI. Proposer's Meeting:**

A mandatory in-person meeting will be held at EZ Ride facility located at 144 Park Place East, Wood-Ridge, NJ 07075, on February 17, 2026, at 11:00 AM. In addition to answering any questions from the attending proposers, we will provide information regarding our concepts for phased redevelopment of the entire site along with a visit to the lot for construction.

Any further questions may be submitted via email no later than 5:00 PM on February 18, 2026. A response to all questions, along with any addendums, if necessary, will be sent to all attendees by February 20, 2026.

**VII. Evaluation Criteria**

The proposals will be reviewed by a selection committee comprising of representatives drawn from trustees of EZ Ride and evaluated based on criteria including but not limited to the following:

1. Relevant previous work
2. Responsiveness to the RFP, understanding of the scope of the project and approach to produce the desired results
3. Qualified personnel
4. Schedule of work listing milestones to be followed

### **VIII. Timeline:**

The tentative timeline is as follows:

5. Evaluation of Proposal completed by March 20, 2026.
6. A virtual presentation may be required – week of March 23, 2026.
7. Contract awarded by April 3, 2026.
8. Construction completion by June 12, 2026.
